## 2016 FAMILY VOLUNTEER DAY SHARE YOUR STORY SWEEPSTAKES

## **OFFICIAL RULES**

Important: Please read these Official Rules before entering this sweepstakes (the "Sweepstakes"). By submitting an entry and participating in the Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

- 1. **Sponsor/Administrator:** This Sweepstakes is sponsored by Points of Light Foundation d/b/a Points of Light Institute, 600 Means Street NW, Suite 210, Atlanta, Georgia 30318 ("Sponsor"). The Sweepstakes is administered by GenerationOn, a program of Sponsor, located at 35 W 35<sup>th</sup> Street, 6<sup>th</sup> Floor, New York City, NY 10001 ("Administrator"), on behalf of Sponsor. - 2. **Eligibility:** The Sweepstakes is offered and open only to persons legally residing in one of the fifty (50) United States or Washington DC who are at least 18 (eighteen) years of age or the age of majority in their state of residence on the date of entry in the Sweepstakes. The directors, officers and employees of Sponsor and Administrator, and each of their respective parents, subsidiaries and affiliated companies, distributors, advertising, promotional and, persons engaged in the development, production or distribution of materials for this sweepstakes and the immediate family members (parent, child, sibling and spouse of each) of, and/or other persons (whether related or not) living in the same household as, such individuals are not eligible to participate in the Sweepstakes. The Sweepstakes is void in Puerto Rico, all US territories and possessions, and where prohibited by law.
- 3. **Sweepstakes Entry Period:** The Sweepstakes starts October 30, 2016 at 12:00:00 PM Eastern Time (ET) and ends December 3, 2015 at 11:59:59 AM ET (the "Sweepstakes Period"). All entries must be received during the Sweepstakes Period and meet the other requirements in these Official Rules to be eligible to potentially win a prize.

## 4. Prizes:

- (a) Grand Prize Description: Each of four (4) grand prizes will consist of one (1) \$500 gift card issued by VISA® subject to the terms and conditions of the issuer, which has no affiliation with the Sponsor or Administrator.
- (b) Runner-up Prize Description: Each of 5 (5) runner-up prizes will consist of the following costs associated with a family night out comprising: A \$100 restaurant gift card that can be used at a range of outlets; plus a \$60 "Fandango" gift card (or equivalent). The gift card(s) will be selected by the Administrator in its sole discretion.
- 5. The Approximate Retail Value (ARV) of each of the Grand Prizes is \$500. The ARV of each of the Runner-up prizes is \$160. Total ARV of all Sweepstakes prizes is \$2,800.00.

Sponsor reserves the right, in its sole discretion, to substitute a prize of equal or greater value if advertised Prizes become unavailable.   - Step 1: Visit the Family Volunteer Day microsite at www.generationon.org/fvd;
  - <u>Step 2</u>: Submit your family's story of service on the Family Volunteer Day microsite; and
  - <u>Step 3</u>: Follow the on-screen instructions to complete the entry form provided and upload a photo.

If any entrant is found to have used multiple or different entries, entries are defined by submissions associated with an email account, such entrant will be disqualified in the Administrator's sole discretion. Limit one (1) entry per person throughout the Sweepstakes Period. All requested information including a photo must be provided to Sponsor for entrant's entry to be valid). All entries must be legible and in English or Spanish. Entries become the exclusive property of Sponsor and will not be acknowledged or returned. All entrants and entries are subject to verification by Sponsor. Sponsor's computer is the official timekeeper for the Sweepstakes.

- 7. **Prize Drawings:** A random drawing to select the prize winners from among all eligible entries received will be conducted by Administrator at 35 West 35<sup>th</sup> Street, floor 6, New York City, NY 10001 on or about December 3rd, 2016. The decisions made by Administrator are final and binding in all matters relating to the Sweepstakes. Odds of winning are subject to the total number of eligible entries received by the entry deadline.
- 8. **Notification of Winners:** Administrator will notify the potential winners by regular mail, email or phone at the postal address, email address or daytime phone number provided with the entry within **three (3) business days** of the drawing date. The potential winners will be required to complete and return an Affidavit of Eligibility/Liability Release, and, where legal, a Publicity Release, within **three (3) business days** of issuance of notification of its winner status. An entrant's failure to complete and return any required information and/or documents in the time noted, or the

Administrator's inability to provide a potential winner notification of the fact that he or she is a potential winner, will result in disqualification of the potential winner involved and an alternate winner will be selected and notified.
